CERTIFICATE OF WATER RIGHT

This is to Certify, That F. C. OXMAN AND A. J. MAARICH

of Durkee , State of Oregon , has made proof to the satisfaction of the STATE WATER BOARD of Oregon, of a right to the use of the waters of Burnt River

a tributary of Snake River for the purpose of rrigation and domestic, under Permit No. 1274 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon and duly confirmed by order of the STATE WATER BOARD of Oregon, made and entered of record in the Record of Proceedings of said Board, at Salem, in Volume 1, at page 410, on the 17th day of October, 1921; that the priority of the right hereby confirmed dates from June 5, 1912

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 6.41 cubic feet per second, or its equivalent in case of rotation. The use hereunder for irrigation shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the lands under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to heneficial use, is 40 acres in the Southeast quarter of Northwest quarter; 40 acres in as follows: the Southwest quarter of Northwest quarter; 20 acres in the Northwest quarter of Southwest quarter; 40 acres in the Northeast quarter of Southwest quarter and 40 acres in the Northwest quarter of Southeast quarter of Section Twenty-nine: 10 acres in the Northeast quarter of Northeast quarter; 20 acres in the Southeast quarter of Northeast quarter; 15 acres in the Northeast quarter of Southwest quarter; 15 acres in the Northwest quarter of Southeast quarter and 10 acres in the Northeast quarter of Southeast quarter of Section Thirty: 20 acres in the Northwest quarter of Northwest quarter; 10 acres in the Southwest quarter of Northwest quarter: 20 acres in the Northeast quarter of Southeast quarter and 20 acres in the Southeast quarter of Southeast quarter of Section Thirty-three: 10 acres in the Northwest quarter of Southwest quarter; 40 acres in the Southe west quarter of Southwest quarter and 20 acres in the Southeast quarter of Southwest quarter of Section Thirty-four, Township Eleven South, Range Forty-three: 20 acres in Lot 2 (SV4NE4) 20 acres in Lot 3 (SE4NV2); 20 acres in Lot 4 (SW4NV2) 15 acres in the Northeast quarter of Southwest quarter and 20 acres in the Northwest quarter of Southeast quarter of Section Three and 20 acres in Lot 1 (SEINEI) of Section Four, Township Twelve South, Range Forty-three, all East of Willamette Meridian, in Baker County, Oregon. Being a total of 505 acres of land.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.

Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for power purposes, as hereby confirmed and limited.
