CERTIFICATE OF WATER RIGHT

This Is to Certify, That SPIERS L. AND MARY WILSON, Deceased

of Route 1, Box 594-A, Cave Junction , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of East Fork Illinois River

a tributary of Rogue River for the purpose of irrigation of 3.3 acres and supplemental irrigation of 4.7 acres

under Permit No. 26705 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 19, 1960

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.16 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW4 SW4, Section 26, T. 40 S., R. 8 W., W. M. Diversion point located 975 feet South and 515 feet East from the W4 Corner, Section 26

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to pne-fiftieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3½ acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to the use of water is limited to the period when the flow of the Illinois River is more than 30 c.f.s. at its mouth and the Rogue River is more than 735 c.f.s.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

A part of James Lowery DIC No. 43, described as follows: Beginning at the Southwest corner of said DIC, thence North along the West ling of said DIC 306 feet; thence East 457 feet, more or less, to the center line of the County road; thence Southwesterly along said center line to the South line of DIC; thence West 427.68 feet to the point of beginning. Less and excepting that portion contained within the County road. All being within Josephine County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
