CERTIFICATE OF WATER RIGHT

This Is to Certify, That

ESTATE OF D. FAVORITE, deceased
By E. L. FAVORITE, Executorof Haines, State of Oregon, has a right
to the use of the waters of Willow Creek and Rock Creeka tributary of Powder River, for the purpose of
irrigation of 117.8 acresand that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Baker County, and the said decree entered of record at Salem, in the Order Record of
the STATE ENGINEER, in Volume 6, at page 291; that the priority of the right thereby
confirmed dates from August 28, 1880 for Tract No. 1 and 1906 for Tract No. 2that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed one-fortieth of one
cubic foot per second per acre; and shall be subject to all other conditions
and limitations contained in said decree

Certificate of water right issued to the Estate of D. Favorite, deceased, by E. L. Favorite, Executor, and recorded at page 4411, Volume 5, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 155.8 acres. Subsequently, the right to the use of water appurtenant to 37.5 acres was canceled by order of the State Engineer entered October 19, 1966. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to the Estate of D. Favorite, deceased, by E. L. Favorite, Executor.

And said right shall be subject to all other conditions and limitations contained in said decree.
The right to the use of the water for the purposes aforesaid is restricted to the lands or place
of use herein described.
