**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That J. L. STANLEY**

of 5205 Gaffin Road, Salem, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of Pudding River for the purpose of irrigation of 12.5 acres

under Permit No. G-1836 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 26, 1961

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.12 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected within Gesner DLC 47, Section 5, T. 8 S., R. 2 W., W. M. Well located 2160 feet South and 540 feet West from the most northerly corner, DLC 47.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

9.6 acres NE $\frac{1}{4}$  NE $\frac{1}{4}$   
2.5 acres NW $\frac{1}{4}$  NE $\frac{1}{4}$   
0.4 acre SE $\frac{1}{4}$  NE $\frac{1}{4}$   
all as projected within Gesner DLC 47  
Section 5  
T. 8 S., R. 2 W., W. M.

Certificate of Water Right issued to J. L. Stanley and recorded at page 31196, Volume 23, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 18.8 acres. Subsequently, the right to the use of water appurtenant to 6.3 acres was canceled by order of the State Engineer entered December 6, 1966. This certificate is issued to confirm the remaining right to the use of water for irrigation and to show the correct place of use, and supersedes the certificate heretofore issued to J. L. Stanley.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
