CERTIFICATE OF WATER RIGHT

This Is to Certify, That ROBERT A. AND LORRAINE STILL
EARL E. AND RUTH O. ROYSE

of Route 3, Box 143, Milton-Freewater, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed spring creek

a tributary of Walla Walla River for the purpose of irrigation of 21.06 acres

under Permit No. 17482 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 25, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.22 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 24, T. 6 N., R. 35 E., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 0.0375 of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be still further limited to a diversion of not to exceed 0.22 cubic foot per second;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

21.06 acres NW $\frac{1}{4}$ NE $\frac{1}{4}$
Section 24
T. 6 N., R. 35 E., W. M.

Land on which water is to be used is a part of that described as follows; Commencing at the NW Corner of the NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 24, T. 6 N., R. 35 E., running thence South 60 rods; thence East 80 rods, more or less, to the line running North and South through the center of the NE $\frac{1}{4}$ of said section; thence North 60 rods, more or less to the section line, thence West 80 rods, more or less to the place of beginning. All being East of Willamette Meridian in Umatilla County, State of Oregon.

Certificate of water right issued to R. K. and G. K. Waller and recorded at page 21064, Volume 15, State Records of Water Right Certificates, confirms the right to the use of water for irrigation of 23.86 acres. Subsequently, the right to the use of water appurtenant to 2.8 acres was canceled by order of the State Engineer entered October 14, 1966. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to R. K. and G. K. Waller.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
