CERTIFICATE OF WATER RIGHT

This Is to Certify. That GRIFFITH FORD, INC.

of Box 206, Westfall , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Fork Indian Creek and Vaughan Reservoir constructed under Application No. R-31192, Permit No. R-2076

a tributary of Malheur River for the purpose of 25% z irrigation of 26.5 acres and supplemental irrigation of 257.7 acres

under Permit No. 25134 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 24, 1957

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.66 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE_4^1 NE_4^1 , Section 15, T. 18 S., R. 39 E., W. M. SE_4^1 NA_4^1 Section 18, T.18 S., R. 40 E. W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow for lands described as primary and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-2076; and further limited to the use of stored water only on lands described as supplemental;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
