

CERTIFICATE OF WATER RIGHT

This Is to Certify. That WALTER J. BLZON

of Route 1, Box 323, Woodburn , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of Champoeg Creek (Willamette River) irrigation of 111.1 acres

for the purpose of

under Permit No. G-2008 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 4, 1961

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.63 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 NE4, as projected within W. West DLC 87, Section 34, T. 4 S., R. 2 W., W. M. Well located 940 feet North and 3550 feet East from the SW Corner, DLC 87.

The amount of water used for irrigation, together with the amount secured under any other

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

25.9 acres NW2 NE1 as projected within J. Johnson DLC 54
10.3 acres SE1 NE1 as projected within J. Johnson DLC 54
20.7 acres SE2 NE2 as projected within W. West DLC 87
1.5 acres NE2 NW2 as projected within J. Johnson DLC 54
1.7 acres SE1 NW2 as projected within J. Johnson DLC 54
10.0 acres SE2 NW2 as projected within W. West DLC 87
13.5 acres NE2 SW2 as projected within W. West DLC 87
10.2 acres NW3 SE3 as projected within W. West DLC 87
