**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That**      **CASCADE RANCHES, INC.**

of **Lake Creek**, State of **Oregon**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a reservoir constructed under Application No. R-41031, Permit No. R-4614

a tributary of \_\_\_\_\_ for the purpose of  
**supplemental irrigation of 72.8 acres**

under Permit No. **30634** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **June 25, 1965**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **52.0 acre feet stored water only**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **SE $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 6, T. 37 S., R. 2 E., W. M.** Diversion point located 150 feet North and 1440 feet East from the SW Corner, Section 6.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to \_\_\_\_\_ of one cubic foot per second per acre, a diversion of **4 $\frac{1}{2}$  acre feet** for each acre irrigated during the irrigation season of each year and shall be further limited to a total diversion of not to exceed **52.0 acre feet per year**;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

14.3 acres NE $\frac{1}{4}$  SW $\frac{1}{4}$   
10.8 acres Lot 6 (NW $\frac{1}{4}$  SW $\frac{1}{4}$ )  
11.8 acres Lot 7 (SW $\frac{1}{4}$  SW $\frac{1}{4}$ )  
34.0 acres SE $\frac{1}{4}$  SW $\frac{1}{4}$   
0.6 acre SW $\frac{1}{4}$  SE $\frac{1}{4}$

1.3 acres NE $\frac{1}{4}$  NW $\frac{1}{4}$
