**CERTIFICATE OF WATER RIGHT**

**This Is To Certify, That** CASCADE RANCHES, INC.,

of Lake Creek, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of two springs, four unnamed streams, West Forks Lake Creek and reservoir constructed under Application No. R-25358, Permit No. R-1081, a tributary of Lake Creek, for the purpose of irrigation of 105.9 acres under Permit No. 19882 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 9, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.32 cubic feet per second; being 0.01 c.f.s. from Spring No. 1; 0.09 c.f.s. from Spring No. 2; 0.20 c.f.s. from each of four unnamed streams, and 0.21 c.f.s. from each of two branches of West Forks Lake Creek

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  SE $\frac{1}{4}$ , SE $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 12, T. 37 S., R. 1 E., W. M. NE $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 7, SE $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 18, T. 37 S., R. 2 E., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed  $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season from April 2 to October 31, of each year; from direct flow and storage from reservoir constructed under Permit No. R-1081;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

From 4 unnamed streams, West Forks of Lake Creek, and reservoir constructed under Permit No. R-1081.

Unnamed Streams: A - 1880 feet North and 2550 feet West; B - 1570 feet North and 2290 feet West; C - 530 feet North and 1300 feet West; D - 140 feet North and 650 feet West, all from the SE Corner, Section 12, T. 37 S., R. 1 E., W. M. West Forks Lake Creek: E - 2050 feet South and 1350 feet East; F - 2200 feet South and 1560 feet East, both from the NW Corner, Section 18, T. 37 S., R. 2 E., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
