CERTIFICATE OF WATER RIGHT

This Is to Certify, That

JOHN L. AND EVELYN M. PATTERSON

of Route 2, Box 339, Camby , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Bear Creek,

a tributary of Rock Creek (Pudding River) (Willamette River) irrigation of 18.0 acres

for the purpose of

under Permit No. 20153 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 26, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.23 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NEL NEL, as projected within Shirley DLC 45, Section 32, T. 4 S., R. 1 E., W. M. Diversion point located 350 feet North and 2620 feet West from the SE Corner DLC 45.

The amount of water used for irrigation, together with the amount secured under any other

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Certificate of water right issued to John L. and Evelyn M. Patterson and recorded at page 22340, Volume 16, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 18.0 acres. Subsequently, the point of diversion for the irrigation of 18.0 acres was transferred by order of the State Engineer entered January 14, 1963, This certificate is issued to confirm a change in point of diversion for irrigation and supersedes the certificate heretofore issued to John L. and Evelyn M. Patterson.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
