## CERTIFICATE OF WATER RIGHT

This Is to Certify, That MRS. MARVIN R. MCDOLE

of Route 1, Box 338, Central Point , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Blackwell Creek and an unnamed gulch

a tributary of Rogue River irr ation of 14.0 acres

for the purpose of

under Permit No. 26932 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 21, 1960

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.17 cubic foot per second; being 0.08 c.f.s. from Blackwell Creek and 0.09 c.f.s from an unnamed gulch

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE4 NE4, NE4 NE4, both as projected within T'Vautt. DIC 37, Section 22, T. 36 S., R. 3 W., W. M. Diversion points located: Blackwell Creek - 2425 feet South and 1020 feet West; Unnamed gulch - Portable pumping\*

The amount of water used for irrigation, together with the amount secured under any other

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed he acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to the use of water is limited to the period when the flow of the Rogue River is more than 1000 c.f.s. immediately above Savage Rapids Dam and more than 735 c.f.s. at its mouth;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
