## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

EVERETT AND BETTY HILBERT

of Diamond , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Dry Krumbo Creek and Kern Bros. Reservoir constructed under Application No. R-21599, Permit No. R-837

a tributary of Krumbo Creek (Blitzen River) irrigation of 298.0 acres

for the purpose of

under Permit No. 16908 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 30, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1000 acre feet

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the • SE<sup>1</sup>/<sub>4</sub> SE<sup>1</sup>/<sub>4</sub>, Section 32, T. 30 S., R. 32 E., W. M. Diversion point located 450 feet East and 1400 feet South from the NW Corner NE<sup>1</sup>/<sub>4</sub> SE<sup>1</sup>/<sub>4</sub>. Section 32.

NE<sup>1</sup>/<sub>4</sub> SE<sup>1</sup>/<sub>4</sub>, Section 32.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 1000 acre feet;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
