CERTIFICATE OF WATER RIGHT

This Is to Certify, That **TRANS-BAY CONSTRUCTION CO., INC.**

of **Little Butte Star Route, Eagle Point** , State of **Oregon** , has made proof to the satisfaction of the **STATE ENGINEER** of Oregon, of a right to the use of the waters of **Rogue River**

a tributary of **Pacific Ocean** for the purpose of
 irrigation of **22.7 acres**

under Permit No. **27260** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **March 14, 1961**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.28 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **NE $\frac{1}{4}$ NW $\frac{1}{4}$** , Section 7, T. 36 S., R. 1 W., W. M. Diversion point located **500 feet South and 1180 feet West from the NE $\frac{1}{4}$ Corner, Section 7.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth of one cubic foot per second per acre**, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **1 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year**; provided further that the right to the use of water is limited to the period when the flow of the Rogue River is more than **1000 c.f.s. at Raygold**, more than **1000 c.f.s. immediately above Savage Rapids Dam** and more than **735 c.f.s. at its mouth**;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.4 acres NE $\frac{1}{4}$ SE $\frac{1}{4}$
 7.2 acres NW $\frac{1}{4}$ SE $\frac{1}{4}$
 8.4 acres SW $\frac{1}{4}$ SE $\frac{1}{4}$
 0.7 acre SE $\frac{1}{4}$ SE $\frac{1}{4}$
 Section 6
 T. 36 S., R. 1 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
