PAUL E. COLDIRON

of Route 1, Box 648, Cottage Grove , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Coast Fork Willamette River and unnamed slough of Row River

a tributary of Willamette River irrigation of 66.6 acres

for the purpose of

under Permit No. 27756 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 14, 1961

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.83 cubic foot per second; being 0.21 c.f.s. from Coast Fork Willamette River and 0.62 c.f.s. from unnamed slough of Row River;

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE2 NW2, as projected within Bower DLC 53, SE2 NW2, as projected within Veach DLC 54, Section 22, T. 20 S., R. 3 W., W. M. Diversion points located: River - 1330 feet South and 2300 feet West; Slough - 3140 feet *

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year; the right allowed herein for appropriation of water from the unnamed slough of Row River shall be limited to the period when the flow of Row River is more than 100 c.f.s. measured at its mouth and when the flow of the Coast Fork Willamette River is more than 135 c.f.s. measured at its mouth; the right allowed herein for appropriation of water from the Coast Fork Willamette River shall be limited to the period when the ** and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
