CERTIFICATE OF WATER RIGHT

This Is to Certify, That PEARL WOODRUFF

of Route 2, Box 145 D., La Grande , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Woodruff wells No. 1 and No. 4

a tributary of Little Creek for the purpose of supplemental irrigation of 173.1 acres

under Permit No. U-582 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 7, 1953

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.16 cubic feet per second; being 2.14 c.f.s. from Well No. 1 and 0.02 c.f.s. from Well No. 4

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 NE 1/4, Section 1, SE 1/4 NE 1/4, Section 11, T. 4 S., R. 39 E., W. M. Wells located: Well No. 1 - 50 feet North and 125 feet West from E 1/4 Corner, Section 11; Well No. 4 - 400 feet South and 275 feet East from N 1/4 *

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Certificate of water right issued to W. H. and Pearl Woodruff and recorded at page 27229, Volume 19, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 252.1 acres. Subsequently, the right to the use of water appurtenant of 79.0 acres was canceled by order of the State Engineer entered February 1, 1967. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to W. H. and Pearl Woodruff.
