CERTIFICATE OF WATER RIGHT

This Is To Certify, That STEPHEN H. FORD

of Route 5, Box 1062, Eugene , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed creek, Coyote creek, and Ford Reservoir constructed under Application No.* a tributary of Coyote creek and Fern Ridge Reservoir for the purpose of irrigation of 152.3 acres
under Permit No. 2242h of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 21, 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.32 cubic feet per second; being 1.01 c.f.s. from unnamed creek, and 0.31 c.f.s. from Coyote creek

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE\frac{1}{2} SW\frac{1}{3}, as projected within Jenkins DIC lili, Section 15; NW\frac{1}{3} NW\frac{1}{3}, SE\frac{1}{4} NW\frac{1}{3}, both as projected within Jenkins DIC lili, Section 22, T. 18 S., R. 5 W., W. M. Diversion points located: 1170 feet South and 190 feet West; 2125 feet South and 2825 feet West; 4090 feet South and 900 feet West; all **

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1516;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.8 acres SW\(\frac{1}{2}\) SW\(\frac{1}{4}\) as projected within Jenkins DIC like 4.6 acres SE\(\frac{1}{2}\) SW\(\frac{1}{4}\) as projected within Jenkins DIC like 7.4 acres SW\(\frac{1}{4}\) SE\(\frac{1}{4}\) as projected within Jenkins DIC like 8.8 acres Lot 1 (SW\(\frac{1}{4}\) SE\(\frac{1}{4}\))
