CERTIFICATE OF WATER RIGHT

This is to Certify, That

- has a right to the use of

the waters of MILL CREEK, a tributary of Catherine Creek and the Grande Ronde River, in Union County, State of Oregon,

for the purpose of irrigation and domestic use, said domestic use being included within the amount of water allowed for irrigation during the irrigation season;

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Union County, and the said decree entered of record at Salem, in the Order Record of the Board of Control of the State of Oregon, in Volume 1, at page 207; that the priority of the right hereby confirmed dates from 1862 for the irrigation of four acres, from 1864 for the irrigation of 13% acres, from 1864, also, at the rate of .01 cubic feet per second, from 1897 for the irrigation of one and one-half acres, from 1893 for the irrigation of one acre, and from 1905 for the irrigation of two acres;

that the amount of water to which such right is entitled and hereby confirmed for the purpose saforesaid, is limited to an amount actually beneficially used for said purpose s, and shall not exceed .05 cubic feet per second as of date 1862, .05 cubic feet per second as of date 1864, .01 cubic feet per second as of date 1864, .02 cubic feet per second as of date 1897, .01 cubic feet per second as of date 1893, and .03 cubic feet per second as of date 1905.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:
