CERTIFICATE OF WATER RIGHT

This Is to Certify, That

STANFORD A. and JANE GOTTER

of Route 2, Box 191-B, Hillsboro , State of Oregon , has made proof to the tatisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of McFee Creak

a tributary of Tualstin River irrigation of 2.3 acres

for the purpose of

under Permit No. 15227 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from Merch 3, 1942

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.029 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NN Mai, as projected within Jas. M. Rowell DLC LL, Section 15, T. 2 S., R. 2 W., Y. H. Diversion point located 180 feet North and 1210 feet West from the NE Corner, DLC LL.

The amount of water used for irrigation, together with the amount secured under any other

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each scre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.3 acres NW NA NW A as projected within Jas. M. Rowell DLC hh Section 15
T. 2 S., R. 2 W., W. M.

Certificate of water right issued to Stanford A. Gotter and recorded at page 19797, Volume 11, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 5.5 acres. Subsequently, the right to the use of water appurtenant to 3.2 acres was canceled by order of the State Engineer entered June 8, 1967. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to Stanford A. Gotter.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
