## CERTIFICATE OF WATER RIGHT

This Is To Certify, That

RUTHELLA HILE VanCLEAVE

of P. O. Box 291, Cottage Grove , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Row River

a tributary of Willamette River irrigation of 0.8 acre

for the purpose of

under Permit No. 15202 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 10, 1942

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second;

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 SW4, as projected within A. Alexander DLC 71, Section 26, T. 20 S., R. 3 W., W. M. Diversion point located 1870 feet South and 410 feet West from the NW Corner, Alexander DLC 70.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year;

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.8 acre SW\(\frac{1}{4}\) SW\(\frac{1}{4}\) as projected within A. Alexander DLC 71

T. 20 S., R. 3 W., W. M.

Land on which water is to be used is part of that described as follows:

Beginning at a point on the westerly Right-of-Way boundary of the County Road No. 623, said point being 30.0 feet west of the center line of said County Road No. 623 at a point 1890.6 feet South, 00° 31' west from the northwest corner of Robert Alexander DIC No. 70 in Section 26, Township 20 South, Range 3 West, W. M.; run thence

west 392.5 feet, thence parallel with said County Road north 00° 31' east 150.0 feet; thence east 392.5 feet; thence south 00° 31' west 150.0 feet to the place of beginning, containing 1.35 acres more or less.

Certificate of water right issued to Claude R. Arne and recorded at page 15477, Volume 13, State Record of Water Right Certificates, confirms a right to the use of water for irrigation of 27.8 acres. Subsequently, the right to the use of water appurtenant to 27.0 acres was cancelled by orders of the State Engineer entered June 11, 1965, and June 21, 1966. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to Claude R. Arne.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
