CERTIFICATE OF WATER RIGHT

This Is to Certify, That THEODORE, ARNOLD, and TURFIELD SCHINDLER

of 980 Lefor Drive, NW, Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Well No. 2

a tributary of Willamette River for the purpose of irrigation of 106.0 acres

under Permit No. G-1474 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 14, 1959

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.09 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 33, T. 7 S., R. 3 W., W. M. Well No. 2 is located 3 chains South and 19 chains West from the S $\frac{1}{4}$ Corner, Section 28.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ~~one-eightieth~~ of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Certificate of water right issued to Theodore, Arnold, & Turfield Schindler and recorded at page 28927, Volume 21, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 214.6 acres. Subsequently, the right to the use of water from Wells Nos. 1 and 3 appurtenant to 108.6 acres was canceled by order of the State Engineer entered July 3, 1967. This certificate is issued to confirm the remaining right to the use of water from Well No. 2 for irrigation and supersedes the certificate heretofore issued to Theodore, Arnold, & Turfield Schindler.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
