CERTIFICATE OF WATER RIGHT

This Is to Certify, That

JAMES AND MYRTLE BUCKLIN

of **P. O. Box 789, Selma**, State of **Oregon**, has made proof to the satisfaction of the **STATE ENGINEER** of Oregon, of a right to the use of the waters of **Oak Flat Creek**

a tributary of **Illinois River** for the purpose of
irrigation of **0.3 acre** and domestic use of one family

under Permit No. **27869** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **February 23, 1962**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.015 cubic foot per second**; being **0.01 c.f.s.** for irrigation and **0.005 c.f.s.** for domestic

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **NW $\frac{1}{4}$ NE $\frac{1}{4}$, SW $\frac{1}{4}$ NE $\frac{1}{4}$** , both as projected within H.E.S. 119, Section 8, T. 37 S., R. 9 W., W. M. Diversion points located: **1570 feet North and 2410 feet East; 370 feet North and 1740 feet East**; both from the *

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-fiftieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **3 $\frac{1}{2}$ acre feet per acre** for each acre irrigated during the irrigation season of each year; provided further that the right to use of water is limited to the period when the flow of the Illinois River is more than **80 c.f.s.** at its mouth and the flow of the Rogue River is more than **735 c.f.s.** at its mouth;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Domestic and 0.2 acre SW $\frac{1}{4}$ NE $\frac{1}{4}$ as projected within H.E.S. 119
0.1 acre SE $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within H.E.S. 119
Section 8
T. 37 S., R. 9 W., W. M.

* most westerly SW Corner, H.E.S. 119.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
