## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That MARVIN E. GRAHAM

of 3962 W. Ella Avenue, Marysville , State of California , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Hankin's Well No. 1h

a tributary of lost River for the purpose of irrigation of 48.9 acres and supplemental irrigation of 138.8 acres

under Permit No. U-700 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 26, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.35 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE\(\frac{1}{4}\) IN\(\frac{1}{4}\), Section 15, T. 38 S., R. 11\(\frac{1}{2}\) E., W. M. Well located 2810 feet West and 2270 feet South from the NE Corner, Section 15.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year; and shall be further limited to the terms and conditions of stipulation recorded in Volume 3, pages 711 and 712, Miscellaneous Records of the State Engineer and by reference made a part hereof.

conform to such reasonable rotation system as may be ordered by the proper state officer.
