CERTIFICATE OF WATER RIGHT

This Is To Certify, That WEST SACRAMENTO ENTERPRISES, INC.

of Fort Rock , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Viewpoints Wells Nos. 1, 2, and 3 a tributary of Ana River (Summer Lake) for the purpose of

irrigation of 466.9 acres

the use of said anators

under Permit No. G-697 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 11, 1957

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 5.8L cubic feet per second; being 3.09 c.f.s. from Well No. 2, 0.90 c.f.s. from Well No. 1, and 1.85 c.f.s. from Well No. 3

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 SW4, Section 18; SW2 SE4, Section 19; SE4 NW4, Section 29; T. 27 S., R. 19 E., W. M. Wells located: 3260 feet North and 80 feet East; 2320 feet South and 2710 feet East, both from the W4 Corner, Section 19; 2110 feet East and 2660 feet North from the SW Corner, Section 29.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
