CERTIFICATE OF WATER RIGHT

This Is To Certify, That SANDY FARMS

of Route 3, Box 173, Boring, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream and reservoir constructed under Appl. No. R-27865, Per. No. R-1441 a tributary of Tickle Creek for the purpose of irrigation of 219.9 acres and supplemental irrigation of 33.2 acres under Permit No. 21838 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 8, 1952

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.69 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 21, T. 2 S., R. 4 E., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-1441;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Certificate of water right issued to Sandy Farms and recorded at page 29812, Volume 21, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 257.1 acres. Subsequently, the right to the use of water appurtenant to 4.0 acres was canceled by order of the State Engineer entered August 7, 1967. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to Sandy Farms.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
