**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** OTTO M. AND MARY R. SHOCKEY

of Route 2, Box 368, Crawfordsville, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Brush Creek

a tributary of Calapooia River for the purpose of irrigation of 22.8 acres

under Permit No. 27955 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 29, 1962

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.29 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  NE $\frac{1}{4}$ , as projected within Woodfin DIC 43, Section 29, T. 14 S., R. 1 W., W. M. Diversion point located 10 feet South and 2340 feet West from the NE Corner, Section 29.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.8 acre SE $\frac{1}{4}$  SW $\frac{1}{4}$   
6.2 acres SW $\frac{1}{4}$  SE $\frac{1}{4}$   
10.8 acres SE $\frac{1}{4}$  SE $\frac{1}{4}$   
all as projected within Woodfin DIC 43  
Section 20

3.2 acres NE $\frac{1}{4}$  NE $\frac{1}{4}$   
1.0 acre NW $\frac{1}{4}$  NE $\frac{1}{4}$   
0.8 acre NE $\frac{1}{4}$  NW $\frac{1}{4}$   
all as projected within Woodfin DIC 43  
Section 29  
T. 14 S., R. 1 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
