for the purpose of

under Permit No. 28741 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 4, 1963

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed. 0.78 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEL NEL, as projected within Cole DLC 39, Section 31, T. 20 S., R. 2 W., W. M. Diversion point located 3280 feet North and 210 feet West from the SE Corner, Section 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to use of water is limited to the period when the flow of the Row River is more than 100 c.f.s. at its mouth and the Coast Fork Willamette River is more than 135 c.f.s. at its mouth;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
