CERTIFICATE OF WATER RIGHT

This Is to Certify, That HOMER A. and INEZ V. DeLAMATER

of Box 142, Beatty, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Sycan River

a tributary of Sprague River for the purpose of irrigation of 136.5 acres

under Permit No. 26785 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 31, 1960

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.71 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2 (NW $\frac{1}{4}$ NE $\frac{1}{4}$), Section 3 and Lot 1 (NE $\frac{1}{4}$ NE $\frac{1}{4}$), Section 10, T. 36 S., R. 12 E., W. M. Diversion points located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

17.8 acres Lot 1 (NE $\frac{1}{4}$ NE $\frac{1}{4}$)
20.0 acres Lot 2 (NW $\frac{1}{4}$ NE $\frac{1}{4}$)
15.0 acres Lot 7 (NW $\frac{1}{4}$ NE $\frac{1}{4}$)
15.6 acres Lot 8 (NE $\frac{1}{4}$ NE $\frac{1}{4}$)
18.6 acres Lot 9 (SE $\frac{1}{4}$ NE $\frac{1}{4}$)
19.5 acres Lot 10 (SW $\frac{1}{4}$ NE $\frac{1}{4}$)
20.0 acres Lot 15 (SW $\frac{1}{4}$ NE $\frac{1}{4}$)
10.0 acres Lot 16 (SE $\frac{1}{4}$ NE $\frac{1}{4}$)
Section 10
T. 36 S., R. 12 E., W. M.

Diversion points located: 320 feet South and 2330 feet West from NE Corner, Section 3, 2240 feet North and 2520 feet East from Center, Section 10.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
