CERTIFICATE OF WATER RIGHT

This Is to Certify, That RICHARD VON

of Route 2, Box 18C-A, McMinnville, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Cain Creek

a tributary of Panther Creek for the purpose of irrigation of 20.7 acres

under Permit No. 28374 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 28, 1962

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.26 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected within Shaw DLC 42, Section 21, T. 3 S., R. 5 W., W. M. Diversion point located 30 feet West and 1020 feet North from SE Corner, Section 21.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.0 acres NE $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within Shaw DLC 46
3.2 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within Shaw DLC 46
6.6 acres Lot 7 (SE $\frac{1}{4}$ SE $\frac{1}{4}$)
Section 21

1.9 acres NW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within Shaw DLC 46
6.0 acres SW $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within Shaw DLC 46
Section 22

1.0 acre NE $\frac{1}{4}$ NE $\frac{1}{4}$
Section 28
T. 3 S., R. 5 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
