CERTIFICATE OF WATER RIGHT

This Is to Certify, That EMIL GENTNER

of R.F.D. No. 1, Murphy, State of Oregon, has a right
to the use of the waters of Applegate River

a tributary of Rogue River for the purpose of
irrigation of 36.1 acres
and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Jackson County, and the said decree entered of record at Salem, in the Order Record of
the STATE ENGINEER, in Volume 16, at page 523; that the priority of the right thereby
confirmed dates from February, 1899

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed 0.514 cubic foot per
second.

The point of diversion is located in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 6, T. 38 S., R. 4 W., W. M.

A description of the place of use under the right, and to which such right is appurtenant, is as
follows:

1.2 acres SW $\frac{1}{4}$ NE $\frac{1}{4}$
2.3 acres SE $\frac{1}{4}$ NW $\frac{1}{4}$
0.5 acre NE $\frac{1}{4}$ SW $\frac{1}{4}$
4.6 acres NE $\frac{1}{4}$ SE $\frac{1}{4}$
15.4 acres NW $\frac{1}{4}$ SE $\frac{1}{4}$
5.7 acres SW $\frac{1}{4}$ SE $\frac{1}{4}$
6.4 acres SE $\frac{1}{4}$ SE $\frac{1}{4}$

Certificate of water right issued to Emil Gentner and recorded at page 32853,
Volume 24, State Record of Water Right Certificates, confirms the right to the
use of water for irrigation of 51.3 acres. Subsequently, the right to the use
of water appurtenant to 15.2 acres was transferred by order of the State Engineer
entered February 6, 1968. This certificate is issued to confirm the remaining
right to the use of water for irrigation and supersedes the certificate heretofore
issued to Emil Gentner.

And said right shall be subject to all other conditions and limitations contained in said decree.
The right to the use of the water for the purposes aforesaid is restricted to the lands or place
of use herein described.
