CERTIFICATE OF WATER RIGHT

This Is to Certify, That

of Route 1, Dayton , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Sweeney Irrigation Well

a tributary of Bertram Creek (West Branch of Palmer Creek) irrigation of 60.0 acres

for the purpose of

of the State Engineer, and that said right to the use of said waters under Permit No. has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 16, 1955 for 0.37 cubic foot per second and November 1, 1955 for 0.01 cubic foot per second

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.38 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE4 NE4, as projected within Smith DLC 48, Section 19, T. 4 S., R. 3 W., W. M. Well located 220 feet South and 550 feet West from Southerly SW Corner, Smith DIC 47.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightleth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year;

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
