CERTIFICATE OF WATER RIGHT

This Is to Certify, That ROSEBURG LUMBER CO.

of P. O. Box 1088, Roseburg, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Umpqua River

a tributary of Umpqua River for the purpose of domestic use in office and plant

under Permit No. 29194 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 12, 1963

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.10 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected within McCloud DLC 41, Section 33, T. 28 S., R. 6 W., W. M. Diversion point located 900 feet North and 160 feet West from SE $\frac{1}{4}$ Corner, Section 33.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - - - of one cubic foot per second per acre. This right shall be subject to the provisions of the State Water Resources Board policy program for the Umpqua Basin adopted on October 24, 1958;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- SW $\frac{1}{4}$ NE $\frac{1}{4}$ as projected within McCloud DLC 41
 - SE $\frac{1}{4}$ NW $\frac{1}{4}$ as projected within McCloud DLC 41
 - NE $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within McCloud DLC 41
 - SE $\frac{1}{4}$ SW $\frac{1}{4}$ as projected within McCloud DLC 41
 - Lot 9 (NW $\frac{1}{4}$ SE $\frac{1}{4}$)
 - NW $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within McCloud DLC 41
 - Lot 2 (SW $\frac{1}{4}$ SE $\frac{1}{4}$)
 - SW $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within McCloud DLC 41
 - SW $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within Phipps DLC 42
 - Lot 1 (SE $\frac{1}{4}$ SE $\frac{1}{4}$)
 - SE $\frac{1}{4}$ SE $\frac{1}{4}$ as projected within Phipps DLC 42
