CERTIFICATE OF WATER RIGHT

This Is To Certify, That GORDON TURNIDGE

of 6961 Wheatland Road, Salem, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Claggett Creek and Clear Lake a tributary of _____ for the purpose of irrigation of 48.77 acres and supplemental irrigation of 36.4 acres under Permit No. 27951 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 28, 1962

; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.83 cubic foot per second; being 0.30 c.f.s. from Claggett Creek and 0.53 c.f.s. from Clear Lake

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected within Smith DLC 69, Section 27; NW $\frac{1}{4}$ NW $\frac{1}{4}$, as projected within Smith DLC 69, Section 26, T. 6 S., R. 3 W., W. M. Diversion points located 1960 feet West and 700 feet South; 310 feet West and 1280 feet South; both from the NE Corner, Smith DLC 69.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the use of the waters of Claggett Creek as allowed herein shall be limited to the lands described as primary;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
