## CERTIFICATE OF WATER RIGHT

This Is to Certify. That C. R. MOORE

of Lake Creek ,State of Cregon , has a right to the use of the waters of South Fork of Little Butte Creek

a tributary of

for the purpose of

irrigation of 18.0 acres and power and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Jackson County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 14, at page 17202; that the priority of the right thereby confirmed dates from February, 1894

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.37 cubic foot per second; measured at the head of the ditch or the point where the same leaves the natural stream, from April 1st to October 1st of each year, for irrigation and 1.0 cubic foot per second for the development of power.

The point of diversion is located in the  $NE_4^1$   $NW_4^1$ , Section 17, T. 37 S., R. 3 E., W. M.

Certificate of water right issued to C. R. Moore and recorded at page 17202, Volume 14, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 19.0 acres and power. Subsequently, the right to point of diversion for the irrigation of 1.0 acre was transferred by order of the State Engineer entered October 3, 1967. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to C. R. Moore.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
