of Route 1, Box 625, Klamath Falls , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Sycan River and Sprague River

a tributary of Williamson River irrigation of 104.4 acres

for the purpose of

under Permit No. 26972 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 24, 1960 for 1.81 c.f.s.

September 16, 1960 for 0.80 c.f.s.;

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.61 cubic feet per second; being 1.01 c.f.s. from Sycan River and 1.60 c.f.s. from Sprague River

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 6 ($S_{\frac{1}{2}}^{\frac{1}{2}}$ $NE_{\frac{1}{4}}^{\frac{1}{4}}$ $NW_{\frac{1}{4}}^{\frac{1}{4}}$); and Lot 24 ($S_{\frac{1}{2}}^{\frac{1}{2}}$ $NE_{\frac{1}{4}}^{\frac{1}{4}}$), Section 10, T. 36 S., R. 12 E., W. M. Diversion points located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Diversion points located: 1170 feet South and 2560 feet East; portable pumping between points located: 1790 feet North and 50 feet West; 1600 feet North and 1220 feet West; all from Center, Section 10;

This certificate is issued to correct and supersede the certificate of water right issued to Edith L. Matney and Estate of Lewis B. Matney, and recorded at page 34900, Volume 26, State Record of Water Right Certificates, so as to correctly show the location of point of diversion.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
