CERTIFICATE OF WATER RIGHT

This Is to Certify, That

PETER W. SCHOENINGH, JR.

of R.F.D., Haines , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of 2 unnamed streams

a tributary of Middy Creek for the purpose of irrigation of 2.5 acres and supplemental irrigation of 71.5 acres and stock use

under Permit No. 28871 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 23, 1962

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.85 cubic feet per second; being 0.79 c.f.s. from South Unnamed Stream and 1.06 c.f.s. from North Unnamed Stream

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NWL NWL; SWL NWL, Section 18, T. 7 S., R. 39 E., W. M. Diversion points located 340 feet South and 40 feet East; 1830 feet South and 120 feet East; both from the NW Corner, Section 18.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortleth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $\frac{3}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that during the time water is being diverted for irrigation no additional water may be diverted for stock. At other times diversion for stock shall not exceed 0.02 c.f.s. from each stream;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
