CERTIFICATE OF WATER RIGHT

This Is to Certify, That

OLEN A. CANAMORE

of Route 2, Box 442, Oregon City , has made proof , State of Oregon to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream and Briscoe Reservoir constructed under Application No. R-37442. Permit No. R-4457 a tributary of for the purpose of Clear Creek irrigation of 3.4 acres, supplemental irrigation of 14.4 acres and fish culture

of the State Engineer, and that said right to the use of said waters under Permit No. 29883 has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 1, 1962

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount usually beneficially used for said purposes, and shall not exceed 0.04 cubic foot per second and 26.3 acre feet; being 0.04 c.f.s. from stream for irrigation and 13.3 a.f. from reservoir for irrigation and supplemental irrigation and 13.0 a.f. from reservoir for fish culture or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the Lot 2 (NW SW1), Section 5, T. 3 S., R. 3 E., W. M. Diversion point located 17 chains North and 2 chains East from the SE Corner of Fordyce DLC 64;

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-4457 and further limited to the use of stored water only on lands described as supplemental;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
