CERTIFICATE OF WATER RIGHT

This Is to Certify, That

GERALD VAN DYKE

of 1000 SW 331st Avenue, Hillsboro , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Dairy Creek and reservoir constructed under Application No. R-41992, Permit No. R-4809

a tributary of Tualatin River for the purpose of irrigation of 29.0 acres and supplemental irrigation of 49.7 acres

under Permit No. 31708 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 15, 1966

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.36 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWI NWI, as projected within Job DLC 50, Section 1, T. 1 S., R. 3 W., W. M. Diversion points located 3330 feet North and 730 feet East: 3250 feet North and 570 feet East: both from the SW Compen. Section 1

feet East; 3250 feet North and 570 feet East; both from the SW Corner, Section 1. The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2 acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-4809 and further limited to the use of stored water only on the lands described as supplemental;

conform to such reasonable rotation system as may be ordered by the proper state officer.
