CERTIFICATE OF WATER RIGHT

This Is to Certify, That **JAMES F. and LURLINE R. COOMAN**

of **Harcross Road, Woodside**, State of **California**, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Fork Long Branch, Peck Gulch, unnamed gulch and 100 acre feet supplemental storage in Wade Reservoir under the provisions of Permit No. R-2365 a tributary of **Little Butte Creek** for the purpose of supplemental irrigation of **38.2 acres**

under Permit No. **26813** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **April 29, 1960**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.48 cubic foot per second; being 0.10 c.f.s. from South Fork Long Branch; 0.29 c.f.s. from Peck Gulch and 0.09 c.f.s. from unnamed gulch**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **SW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 10; NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 15; SE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 14, T. 36 S., R. 2 E., W. M.** Diversion points located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed **4 $\frac{1}{2}$ acre feet per acre** for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-2365; the amount allowed herein, together with the amount secured under any other right existing for said lands, shall be limited by the duty of water as fixed herein; provided further that the right to the use of direct flow of water is limited to the period when the flow of the Rogue River is more than **1000 c.f.s. at Raygold, more *** and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.0 acres **SE $\frac{1}{4}$ SW $\frac{1}{4}$**
28.2 acres **SE $\frac{1}{4}$ SE $\frac{1}{4}$**
Section 16
T. 36 S., R. 2 E., W. M.

Diversion points located: Reservoir - 1020 feet North and 2540 feet West; South Fork Long Branch - 475 feet South and 70 feet West; Peck Gulch - 2080 feet South and 2000 feet East; Unnamed Gulch - 2260 feet South and 2075 feet East; all from the NW Corner of Section 14.

* than 1000 c.f.s. immediately above Savage Rapids Dam and more than 735 c.f.s. at its mouth;

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
