CERTIFICATE OF WATER RIGHT

This Is to Certify, That

JAMES F. and LURLINE R. COONAN

of Harcross Road, Woodside

to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Maple Creek and 150.0 acre feet supplemental storage in Wade Reservoir under the provisions of Permit No. R-2706

a tributary of Little Butte Creek

supplemental irrigation of 56.4 acres

under Permit No. 27726 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 21, 1961

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.71 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SWL SEL, Section 10; NWL NEL, Section 11, T. 36 S., R. 2 E., W. M. Diversion points located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-2706; the amount allowed herein, together with the amount secured under any other right existing for said lands, shall be limited by the duty of water as fixed herein; provided further that the right to use of direct flow shall be limited to the period when the flow of the Rogue River is more than 1000 c.f.s. at Raygold, more * and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

34.7 acres SW1 SW1 Section 15

Diversion points located: Reservoir - 1020 feet North and 2540 feet West from the SE Corner, Section 10; Maple Creek - 480 feet South and 410 feet East from the $N_{\frac{1}{4}}$ Corner, Section 11.

* than 1000 c.f.s. immediately above Savage Rapids Dam and more than 735 c.f.s. at its mouth;

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
