a tributary of Thomas Creek for the purpose of irrigation of 18.1 acres and supplemental irrigation of 601.9 acres under Permit No. G-2095 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 5, 1961

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.35 cubic feet per second; being 0.23 c.f.s. from Wells No. 1 and 2 for primary irrigation and 2.12 c.f.s. from Well No. 2 for supplemental irrigation.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW_{4}^{1} , NW_{4}^{1} , Section 5; NW_{4}^{1} , NE_{4}^{1} , Section 6, T. 39 S., R. 20 E., W. M. Wells located: No. 1 - 80 feet South and 2630 feet East; No. 2 - 80 feet South and 60 feet East; both from the N_{4}^{1} Corner, Section 6.

The amount of water used for irrigation, together with the amount secured under any other eight existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year;

conform to such reasonable rotation system as may be ordered by the proper state officer.
