This Is to Certify, That

of Route 3, Box 187, Newberg , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed creek and Bourland Reservoir constructed under Application No. R-37450, Permit No. R-2988

\(\) a tributary of Hawn Creek

for the purpose of

irrigation of 12 71 acres and supplemental irrigation of 37.4 acres

under Permit No. 28105 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 6, 1962

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.54 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEL SEL, as projected within Milligan DLC 43, Section 2, T. 4 S., R. 4 W., W. M. Diversion point located 1340 feet North and 970 feet West from most Southerly SW Angle Corner, Milligan DLC 43.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit No. R-2988;

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
