## CERTIFICATE OF WATER RIGHT

irrigation of 191.0 acres, and stock water for Tract No. 2, and irrigation of 129.9
and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Klamath County, and the said decree entered of record at Salem, in the Order Record of
the STATE ENGINEER, in Volume 10, at page 236; that the priority of the right thereby
confirmed dates from 1880 for Tract No. 1, and 1900 for Tract No. 2

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one-fortieth of a cubic foot per second per acre, prior to June 15, and one-eightieth of a cubic foot per second per acre after June 15, with a total limitation of three acre feet per acre from March 1 to October 1 of each year;

Certificate of water right issued to J. O. Watts and recorded at page 10004, Volume 9, State Record of Water Right Certificates, confirms the right to the use of water for irrigation of 150.6 acres. Subsequently, the right to the use of water appurtenant to 20.7 acres was canceled by order of the State Engineer entered August 2, 1968. This certificate is issued to confirm the remaining right to the use of water for irrigation and supersedes the certificate heretofore issued to J. O. Watts.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
