CERTIFICATE OF WATER RIGHT

This is to Certify, That MILES LEE AND E. A. VAN SICKLIN

of Baker , State of Oregon , has made proof to the satisfaction of the STATE WATER BOARD of Oregon, of a right to the use of the waters of Pine Creek

a tributary of Powder River for the purpose of irrigation and domestic under Permit No. 410 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon and duly confirmed by order of the STATE WATER BOARD of Oregon, made and entered of record in the Record of Proceedings of said Board, at Salem, in Volume 1 , at page 421 , on the 16th day of November, 1921; that the priority of the right hereby confirmed dates from August 22, 1910

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 13.48 cubic feet per second, or its equivalent in case of rotation. The use hereunder for irrigation shall conform to such reasonable rotation system as may be ordered by the proper state officer.
