**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That**      C. E. JONES

of Route 3, Box 526, Corvallis, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of Willamette River for the purpose of irrigation of 34.4 acres

under Permit No. G-1334 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 22, 1959

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.43 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$  NE $\frac{1}{4}$ , SE $\frac{1}{4}$  NE $\frac{1}{4}$ , both as projected within Baker DLC 59, Section 35, T. 12 S., R. 5 W., W. M. Well located 1175 feet South and 3900 feet East from the NW Corner, Baker DLC 59.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ~~one-eighth~~ one-eighth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

7.2 acres NE $\frac{1}{4}$  NE $\frac{1}{4}$  as projected within Baker DLC 59  
19.8 acres SE $\frac{1}{4}$  NE $\frac{1}{4}$  as projected within Baker DLC 59  
0.5 acre NE $\frac{1}{4}$  SE $\frac{1}{4}$  as projected within Baker DLC 59  
Section 35

0.3 acre Lot 12 (SW $\frac{1}{4}$  NW $\frac{1}{4}$ )  
6.4 acres SW $\frac{1}{4}$  NW $\frac{1}{4}$  as projected within Baker DLC 59  
0.1 acre NW $\frac{1}{4}$  SW $\frac{1}{4}$  as projected within Baker DLC 59  
0.1 acre Lot 11 (NW $\frac{1}{4}$  SW $\frac{1}{4}$ )  
Section 36  
T. 12 S., R. 5 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
