## CERTIFICATE OF WATER RIGHT

This is to Certify, That H. C. SHUMAKER, NATHAN HENDERSON, T. M. POST MORTGAGE COMPANY FOR AMERICA, c/o Nathan Henderson

of Laiclaw , , State of Oregon , has made proof to the satisfaction of the STATE WATER BOARD of Oregon, of a right to the use of the waters of Squaw Creek .

a tributary of Deschutes River for the purpose of irrigation and domestic under Permit No. E. 6 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon and duly confirmed by order of the STATE WATER BOARD of Oregon, made and entered of record in the Record of Proceedings of said Board, at Salem, in Volume 1, at page 421, on the 16th day of November, 1921; that the priority of the right hereby confirmed dates from April 12, 1909

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.83 cubic feet per second, or its equivalent in case of rotation. The use hereunder for irrigation shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the lands under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the lace where such water is put to beneficial use, is 1 3 acres in the Southwest quarter of Southwest quarter of Section Twenty-six: 20 acres in the Southeast quarter of Southeast quarter of Section Twenty-seven: 232 acres in the Northeast quarter of Northeast quarter of Section Thirty-four: 23 acres in the Northwest quarter of Northwest guarter of Section Thirty-five: IS acres in the Northeast quarter of Southwest quarter; 15 acres in the Southeast quarter of Southwest quarter; 12 acres in the Southwest quarter of Southwest quarter; 8 acres in the Northwest quarter of Southwest quarter of Section Twenty-nine: 2 acres in the Northeast quarter of Southeast quarter; 27 acres in the Southeast quarter of Southeast quarter of SectionThirty-two: 27 acres in the Southwest quarter of Southwest quarter of Section Thirty-three: Township Fifteen South, Range Eleven: 7.7 acres in Lot 3 (SEANWA) and 25 acres in the Northeast quarter of Southwest quarter of Section Six, Township Sixteen outh, Range Eleven; All East of Willamette Meridian, in Deschutes County, Oregon. Being a total of 218.20 acres.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.

Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for power purposes, as hereby confirmed and limited.
