that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.63 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 9 ($SW_{+}^{L} SE_{+}^{L}$), Lot 10 ($SE_{+}^{L} SE_{+}^{L}$), Section 15, T. 10 S., R. 2 W., W. M. Diversion points located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year; and provided further that water is to be diverted from Novak Slough when available and any deficiency in the available supply in Novak Slough is to be made up by diversion from Thomas Creek providing that the total quantity diverted from both streams shall not exceed 0.63 c.f.s.
