CERTIFICATE OF WATER RIGHT

This is to Certify, That A. D. DEAN, ALSON and FLORENCE JONES

of Baker , State of Oregon , has made proof to the satisfaction of the STATE WATER BOARD of Oregon, of a right to the use of the waters of Overflow or stirplus water from municipal reservoir of City of Baker a tributary of for the purpose of irrigation under Permit No. 4789 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon and duly confirmed by order of the STATE WATER BOARD of Oregon, made and entered of record in the Record of Proceedings of said Board, at Salem, in Volume 1 , at page 429 , on the 9th day of February, 1922; that the priority of the right hereby confirmed dates from September 10, 1920

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed cubic feet per second, or its equivalent in case of rotation. The use hereunder for irrigation shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the lands under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows: (Dean) 1:24 acres in Block 15 of Kellogg's Addition to the City of Baker; being within the NWINWI of Section 20, Township 9 South, Range 40 East of Willamette Meridian, in Baker County, Oregon.) (Jones) 3.3 acres in Blocks 16,17,18,19, Kellogg's Addition to

(Jones) 3.3 acres in Blocks 16,17,18,19, Kellogg's Addition to the City of Baker, being within the NW1NV1 Of Section 20, Township 9 South, Range 40 East of Willamette Meridian: Also 8.46 acres in Blocks 3,4 and 6 of Sally's Addition to the City of Baker, being within the NE1NE1 of Section 19, Township 9 South, Range 40 East of Willamette Meridian, in Baker County, Oregon. Containing in all 13 acres of land.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.

Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for power purposes, as hereby confirmed and limited.
