of Creswell . State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Lynx Hollow Creek

a tributary of Coast Fork Willamette River supplemental irrigation of 62.2 acres

for the purpose of

under Permit No. 29139 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 18, 1963

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.78 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NEL SWL, as projected within Moriss DLC 39; SWL SWL, as projected within Noland DLC 40, Section 12, T. 19 S., R. 3 W., W. M. Diversion points located below:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to use of water is limited to the period when the flow of the Coast Fork Willamette River is more than 135 c.f.s. at its mouth;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.5 acres NEL SWL as projected within Morss DLC 39
5.6 acres NEL SWL as projected within Noland DLC 40
21.5 acres NWL SWL as projected within Noland DLC 40
23.0 acres SWL SWL as projected within Noland DLC 40
4.4 acres SEL SWL as projected within Noland DLC 40
1.2 acres SEL SWL as projected within Noland DLC 40
1.2 acres SEL SWL as projected within Morss DLC 39
Section 12
T. 19 S., R. 3 W., W. M.

Diversion points located 1890 feet East and 250 feet North; 750 feet East and 770 feet South; both from the ME Corner, Pierce DLC 45.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
