**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That DONALD P. BARRETT**

of Kellogg Star Route, Box 20, Oakland, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Calapooya Creek

a tributary of Umpqua River for the purpose of irrigation of 83.4 acres

under Permit No. 29421 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 28, 1964

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.00 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected within Williamson DLC 55, Section 7, T. 25 S., R. 5 W., W. M. Diversion point located 5140 feet South and 1720 feet East from W $\frac{1}{4}$  Corner, Section 6.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right to use of water is limited to the period when the flow of Calapooya Creek is more than 12 c.f.s. at its mouth;

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

19.0 acres NE $\frac{1}{4}$  NW $\frac{1}{4}$  as projected within Williamson DLC 55  
17.9 acres NW $\frac{1}{4}$  NW $\frac{1}{4}$  as projected within Williamson DLC 55  
2.0 acres NW $\frac{1}{4}$  NW $\frac{1}{4}$  as projected within Medley DLC 56  
4.8 acres SW $\frac{1}{4}$  NW $\frac{1}{4}$  as projected within Medley DLC 56  
17.0 acres SW $\frac{1}{4}$  NW $\frac{1}{4}$  as projected within Williamson DLC 55  
22.7 acres SE $\frac{1}{4}$  NW $\frac{1}{4}$  as projected within Williamson DLC 55  
Section 7  
T. 25 S., R. 5 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
