CERTIFICATE OF WATER RIGHT

This Is to Certify, That

WALTER A. WOODARD

of P. O. Box 97, Cottage Grove , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Coast Fork Willamette River and Currin Creek and reservoir constructed under Appl. No. R-40814 and Permit No. R-4572 for the purpose of irrigation of 4.7 acres and bird sanctuary

under Permit No. 30408 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 29, 1965

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.08 cubic foot per second; being 0.06 c.f.s. from River for irrigation, and 0.02 c.f.s. from Creek and reservoir for bird sanctuary,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEL NEL NEL Section 5, T. 21 S., R. 3 W., W. M. Diversion points located: River - 1900 feet South and 920 feet West; Creek - 1370 feet South and 300 feet West, both from the NE Corner. Section 5.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year. The right allowed herein for bird sanctuary shall be subordinate and inferior to all future rights for beneficial consumptive uses,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Bird Sanctuary and 2.8 acres $NE_{L}^{1} NE_{L}^{1} NE_{L}^{1}$ 0.7 acre $NW_{L}^{1} NE_{L}^{1} NE_{L}^{1}$ 8 acres $NW_{L}^{1} NE_{L}^{1} NE_{L}^{1}$ 8 Bird Sanctuary and 1.0 acre $SE_{L}^{1} NE_{L}^{1} NE_{L}^{1}$ all as projected within Cooley DLC 43 Section 5 To 2! S., R. 3 W., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
